

CHPP Monday Night Prayer Call

May 9, 2022



Speaker: Our speaker was Frank Seignious. For decades, Frank and his colleagues have been carefully monitoring key issues on the docket at the Supreme Court.

Frank spoke on the leak regarding the upcoming decision on Roe v/ Wade from the Supreme Court. He spoke on Justice Alito's leaked opinion.



No Constitutional Basis:

He shared that there is nothing in the Constitution or the Bill of Rights to guarantee the "right to abortion". This "right to have an abortion" for a woman has been pulled out of thin air and has no legal or constitutional basis.

The Constitution does not confer the right to an abortion. This must be returned to the people and to their elected officials. If it was wrong before, it must be overturned today.

Historical Look at Abortion Rights:

The respondents (the pro-abortionists) have no persuasive answer to the historical evidence that abortion has always been illegal. There is no historical evidence for this argument.

He states in his opinion:

The court must overturn Roe, Alito argues, because "[t]he Constitution makes no reference to abortion, and no such right is implicitly protected by any constitutional provision . . . including the Due Process Clause of the Fourteenth Amendment."

We need to pray this into reality.

Roe v Wade was an abuse of judicial authority. The decision has had damaging consequences. It has inflamed debate. It is time to heed the constitution and to return this issue to the people at the state level. That is what the Constitution and the rule of law demand.

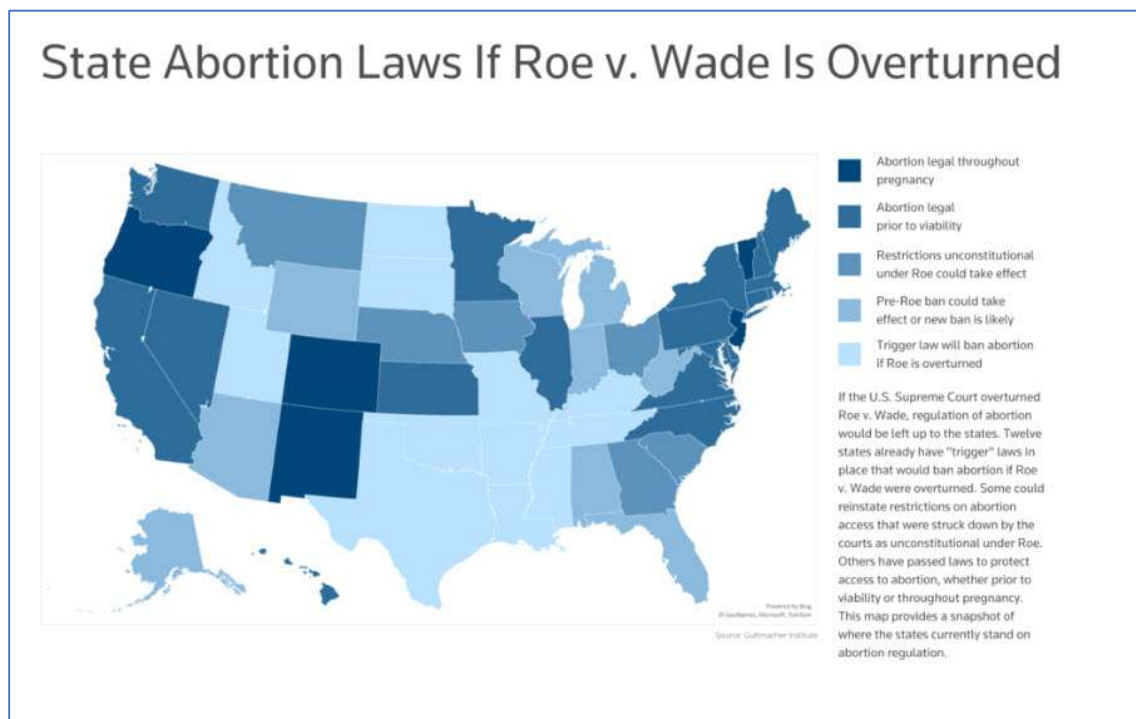
Safe Haven for Babies:

Next Steps and Where Abortion Could Be Illegal In a Month

With *Roe v. Wade* likely to be overturned soon, the question of the legality of abortion will be left with the states. Many states have "trigger laws" on the books that will outlaw abortion as soon as it is constitutional to do so. FindLaw has a [map showing where abortion will be outlawed](#) once the court issues its final opinion in June.



From Sara: There is now a bill in the Congress that would codify abortion in all 50 states, sponsored by Chuck Schumer. SB4132, they will be voting it on Wednesday, May 11. It would legalize abortion in all 50 states. It would knock down the "heartbeat bills" that have been passed in some states.

We prayed against this bill that it would be voted down. We declare that this covenant of death is void and annulled.
